### RENTER ASSURES THE FOLLOWING:

- A 120 V electrical outlet within 10 feet of the desired booth location.
- A space 5'x5'x 8' for the booth, 2 chairs and a table.
- 1 Hour and 30 minutes allocated for the set up of the booth prior to the contracted start time.
- That renter is responsible for any damage done to the photo booth by renter and/or guests.

### WHITE ELEPHANT IMAGES, LLC OBLIGATIONS ARE THE FOLLOWING:

- Provide unlimited photos for the duration of the agreed upon time span.
- Provide (1) photo album for the client along with (1) personalized keepsake card for *each* guest.
- Provide a qualified and friendly technician to assure proper use and results.
- Delivery, set up and tear down of the booth will be done in a timely manner.
- Delivered to the client (1) personalized C.D. of all photos captured during the event (this includes full right to manipulate and reprint images).

### OTHER:

- Client and White Elephant Images, LLC agrees that in the event of a mechanical failure, or for any reason or inability to perform such that White Elephant Images, LLC cannot provide a functioning photo booth, that White Elephant Images, LLC's maximum liability is the return of any payments received. If only partial services can be provided due to conditions beyond White Elephant Images, LLC reasonable control, then charges are to be prorated.
- Deposit is required to hold the date and the remaining balance is due 10 days prior to the event. If balance due is not paid on time, deposit shall be forfeited and the photo booth reservation canceled. If client cancels event, one half of the deposit will be refunded.
- The photo booth can operate outdoors, on pavement or grass; however, inclement weather requires the booth to be located indoors.
